

Policy for Use of Grand Lake Baptist Assembly and the Cabins Therein

1. Grand Lake Baptist Assembly facilities are available for rent to Southern Baptist Churches or Baptist groups whose purpose is not incompatible with that of Northeastern Baptist Association.

2. The rental of Grand Lake Baptist Assembly and the cabins therein are to be coordinated through the Camp Manager. At least two weeks notice is to be given for the use of any cabins or GLBA facilities.

3. Fees for leasing the campgrounds are as follows:
The GLBA camp facilities are \$4,000.00 per week
(Monday 12:00 pm – Friday 12:00 pm)
Extra days are \$900.00 per day

An additional \$14.00 per camper, per week fee for less than 300 campers;
From 301 to 600 campers the charge is \$12.00 per camper, per week,
and over 600 campers the charge is \$10.00 per camper per week

Weekly leasing the camp grounds includes the use of the kitchen, dining hall, tabernacle, swimming pool, guest house, cook's quarters, nurse's quarters, (no medications provided), recreation areas and teaching pavilions. Sports equipment is not provided. Use of the individual church cabins must be arranged with the owner church.

4. Each leasing group will pay a damage deposit as follows:

For a one day outing (not overnight)	\$100.00
For overnight	\$200.00
For 2-4 nights	\$300.00

This damage deposit plus 50% of the rental fee must be paid at the time of application. The damage deposit, less any damages, will be returned within ten days after the group leaves the camp. If the damages exceed the amount of the deposit, the group will be charged accordingly.

5. The general policy of refunds on deposits and rental fees shall be as follows:
a. If a rental is cancelled before March 1st all deposits and rental fees will be refunded
b. If a rental is cancelled after March 1st but before April 1st the deposits will be retained and the rental fees will be refunded.
c. If rental is cancelled after April 1st there will be no refunds.

6. The following policies shall apply to all groups using all or part of Grand Lake Baptist Assembly:

A. Each group is responsible for clean up of all facilities used. Any necessary clean up cost after the group leaves will be deducted from the damage deposit.

B. Each group is responsible for providing it's own insurance. Proof of insurance will be required on application for use of camp.

C. A list of the names of campers and sponsors will be provided to GLBA upon arrival at the camp.

D. Each group will abide by the rules of the camp, a copy of which will be provided with the application form.

E. Each group using the swimming pool must provide a lifeguard with Red Cross certification and give evidence of such certification to the Camp Manager before use of the pool is allowed.

F. Each group is responsible for it's own security.

G. Automobiles and buses must use designated driveways and parking areas and should remain parked except for entering or leaving the campground.

H. Speed limit is 5 mph throughout the entire camp.

I. A sponsor (21 or older) must be with campers at all times

We suggest one sponsor for every ten campers.

Weekend Use and Retreat Rental Costs

1. Individual facilities at the camp may be rented without renting the whole camp. Individual rental fees per day will be as follows:

Kitchen and Dining Hall	\$450.00 per day
Swimming Pool	\$300.00 per day
Tabernacle	\$600.00 per day

2. Weekend cabin use is to be coordinated through the camp manager. Two weeks notice shall be given for the use of any facilities on the grounds of Grand Lake Baptist Assembly.

There is a \$1.00 per person charge when any GLBA facilities are rented.

There is a \$3.00 per person charge if no GLBA facilities are rented.
